A MESSAGE FROM THE HEALTH COMMISSIONER

Dear Community Members:

While I wish I was starting this weekly coronavirus update with better news to report, good news is unfortunately not the reality in Medina County at this time. The coronavirus surge continues to rage on in Medina as well as all throughout the state. Current data is telling us cases are steadily increasing and worsening week to week. Hospital capacity in our area is becoming a concern as cases continue rise.



Medina County will likely move from risk level 3 to risk level 4 in the Ohio Public Health Advisory System by either this week or next if this trend continues.

With the mix of coronavirus, flu, and seasonal cold sharing similar symptoms, we are asking that if you are sick to self-quarantine and seek testing. There are several locations in Medina County to get tested. A list of those places can be found on our website here: https://medinahealth.org/community/current-outbreaks/testing/

It depends on each location, but most labs are able to turnaround test results within 2-3 days or sooner. It's important that during the time you're waiting for results that you stay home from work or school, even if you aren't feeling that sick. When a lab receives a positive test result, there is a process before that positive test result is reported to the Health Department. The volume of cases has delayed this process and you will likely be notified by your provider or through your online medical chart before your test makes its way to our department.

If you are in a high risk group, a student, or work in a sensitive occupation such as a first responder or medical worker, you can help us by calling the Health Department at 330-723-9688, option 2 as soon as you are made aware of your positive test. Letting anyone know who you came into contact with 48 hours before your symptoms started can help prevent more spread from taking place.
